

DIRECTIONS FOR USE

FAIRWAY MAINTENANCE RATE: For excellent residual color and slow growth, the application rate is 4 bags per acre for 8 to 12 weeks of residual growth and color. For improved stress management, the rate is 2 bags per acre per month during hot weather.

AERATION & LATE FALL PROGRAM: These applications provide an excellent opportunity to add life and energy back into the soil. The application rate is 4 bags per acre.

BERMUDAGRASS PROGRAM: For residual color and enhanced nutrient management, the application rate is 3 bags per month, especially, during times of stress. The product is ideal for winter application on Bermudagrass at a rate of 4 bags per acre for 12 weeks of color.

TEE RECOVERY PROGRAM: For improved turf recovery, the application rate is 4 bags per acre per month. This will improve the overall playability and quality of the tees.
